Course: Eight lane, outdoor, 25 yard pool with non-turbulent lane dividers. Colorado start and automatic timing system with touch pads, 1 button and 8 -lane time display board will be used. A separate 25 -yard warn-up pool will be available throughout the meet. The competition course has not been certified in accordance with 104.2.2(c).

The minimum water depth, measured in accordance with Article 103. 2. 3. is 6 feet 5 inches at the start end and 6 feet 5 inches at the turn end.

Eligibility: 1. Open to any USA Swimming athlete holding a current USA Swimming registration card that is a member of SAC-AZ, FORD-AZ, AZM-AZ and WSF-AZ or UNAT and training with those teams.
2. All swimmers, coaches, and officials must be registered prior to the competition and present proof of current registration to the Clerk of Course, if requested. All coaches and officials shall wear their current USA Swimming registration in a visible manner.
3. Swimmers must be age 13 or older to compete in this meet.
4. Swimmer's age on December 18, 2010 will govern for this meet.
5. This is a NO TIME STANDARD Meet.
6. Swimmers with a disability are welcome to enter this meet. The coach or entry chairperson must alert the Meet Director as to the need for any special accommodations or seeding arrangements.
Rules: 1. The current USA Swimming rules of competitive swimming will govern.
2. This will be a timed final meet. Two swimmers from each team to be seeded in fastest heat of each event.
3. This will be a Short Course Yards (25Y) meet.
4. Swimmers are limited to three (3) individual events and two (2) relays.
5. No Time Trials will be offered during this meet.
6. The Arizona controlled meet warm-up will be enforced and posted.

Entries: Entries must be submitted in a COMMLINK file by e-mail.
Entries must be received by Monday, December 13, 2010.
Late entries will be accepted subject to a $\$ 5$ late fee depending on lane availability up to 30 minutes prior to the start of each session. Bring one (1) team check to the meet for entry fees, payable to Scottsdale Aquatic Club.
