Course: Eight lane, outdoor, 25 yard (or meter) pool with non-turbulent lane dividers. Colorado start and automatic timing system with touch pads and time display board. A warm-up pool will be available for continuous warm-up throughout the meet.

Eligibility:

1. Open to any USA Swimming registered athlete, **who is a member of Sun Devil Aquatics, Scottsdale Aquatics, or Ford Aquatics**, holding a current valid USA card. Unattached swimmers who swim with Ford, SAC or SDA are also eligible to compete. Swimmers must be aged 13 & Older on day of meet to compete.
2. All swimmers, coaches & officials must be registered prior to the competition and present proof of current registration to the Clerk of Course, if requested. All Coaches & officials shall wear their current USA Swimming registration in a visible manner.
3. **There will be no on deck registration.**
4. Swimmer's age on December 12, 2009 will govern for this meet.
5. This is a non-time standard meet.
6. Swimmers with a disability are welcome to enter this meet. The coach or entry chairperson must alert the meet director, referee, and entry coordinator as to the need for any special accommodations or seeding arrangements at the time the entry is submitted.

Rules:

1. The current USA Swimming rules for competitive swimming will govern.
2. This is a timed final meet, using dual meet seeding.
3. Swimmers are limited to three (3) individual events per day and two (2) relays.
4. Entry times must be the swimmers best short course times. Time trials will not be offered.
5. The Arizona Controlled Meet Warm-up Procedure will be enforced and posted.
