Course: Eight lane, outdoor, 25yard pool with non-turbulent lane dividers. Colorado start and automatic timing system with touchpads, 1 button and 8-lane time display board will be used. A separate 25-yard warm-up pool will be available throughout the meet. The competition course has not been certified in accordance with 104.2.2(c).

Eligibility:

1. Open to any USA Swimming athlete holding a current USA Swimming registration card.
2. All swimmers, coaches, and officials must be registered prior to the competition and present proof of current registration to the Clerk of Course, if requested. All coaches and officials shall wear their current USA Swimming registration in a visible manner.
3. Swimmer's age on February 20, 2010 will govern for this meet.
4. This is a NO TIME STANDARD Meet.
5. Swimmers with a disability are welcome to enter this meet. The coach or entry chairperson must alert the Meet Director as to the need for any special accommodations or seeding arrangements.

Rules:

1. The current USA Swimming rules of competitive swimming will govern.
2. This will be a timed final meet.
3. This will be a Short Course Yards (25y) meet.
4. Swimmers are limited to three (3) individual events.
5. The Arizona controlled meet warm-up will be enforced and posted.
6. No Time Trials will be offered during this meet.
7. The 1000/1650 Free requires POSITIVE CHECK-IN by 1:30pm in order to swim these events. Events will be combined and grouped by distance.

Entries: Entries must be on enclosed Arizona Swimming Entry Form or a COMMLINK file. Teams sending Electronic entries must submit a HARD COPY with a single team payment.

Entries must be received by Friday, February 12, 2010.

Late entries will be accepted subject to a \$5 late fee depending on lane availability up to 30 minutes prior to the start of each session. Fees must accompany entries and are non-refundable. Entries without payment will not be accepted.
